PSE has a program called "Sponsorship" to help make this happen. The Sponsorship Subcommittee sends out requests for assistance to see if you and your chapter can help those chapters that do not receive enough money in rebates send delegates to convention.

You must also submit the Registration Form for Delegates and Alternates when returning your sponsorship request. **If we do not receive both pieces, it will cause a delay in processing your request for sponsorship.** Sponsorship Subcommittee will make your hotel reservations (you will be expected to share a hotel room with another sponsored delegate). **Sponsored delegates who choose not to share a room, will be expected to pay half of the hotel cost.** All other expenses will be your chapter's responsibility.
